## 37th EUROCC (Portugal 2014) - Regulations

- 1. Applications must be submitted through the CLUBS.
- 2. For reasons of parking capacity and organization of the visits, the **maximum number of participants in the main event** will be limited to 650 motorhomes and / or 1,300 persons. **Extension limited to (a)** motorhomes and / or (a) people. Gala dinner and extension are optional. For the gala dinner at the Casino, a proper attirement is required (jeans and tennis are not accepted).
- 3. The main event will take place with a **minimum participation** of 300 motorhomes and / or 600 people confirmed by March 06, 2014. The extension will take place with a **minimum participation** of 120 motorhomes and / or 240 people confirmed by March 06, 2014.
- 4. In the eventuality of applications exceeding the numbers above a waiting list will be created and filled in order of arrival of the application forms. Places, resulting from desistances or the possible increase in capacity of the main event or of the extension, will be allocated in order of registration on the waiting list.
- 5. <u>Attention</u>: Inscription bulletins will be processed in order of arrival and will be confirmed with the full and timely payment done by each club. We invite clubs to take the appropriate measures in order to respond to their affiliates choices.
- 6. Payment by bank transfer of the global value via the CLUBS on the following bank account:

- 7. Any application form that is incomplete or not accompanied by full payment will not be taken into account. If the corrected application arrives after the registration deadline, it will be registered on the waiting list.
- 8 Only well justified desistances will be accepted. Given the complexity of the Organization and the significant costs that will be advanced by the FPA in benefit of the participants, a penalty is foreseen for defections desistances. The penalty will be applied as follows:
- A) Retention of 10% of the total paid for desistance requests submitted until March 06, 2014.
- B) Retention of 50% of the total paid for desistance requests submitted between March 07, 2014 and March 31, 2014
- C) Retention of 100% of the total paid for claims of desistance requests made after March 31, 2014.

However, if of the sum of desistances pertaining to articles B) and C) do not exceed 10% of the total confirmed by March 06, 2014 (the historical percentage of cancellations of the EUROCC in the last years has been 6-8%), only a deduction of 30% of the total paid will be in effect.

- 9. The Clubs may substitute one crew by another (main event, gala dinner and extension) after informing the Organization and submitting a new application form.
- 10. Any exclusion, decided by the Organization (misconduct, dog wandering, etc...) will not be refundable.
- 11. The crews must arrive on site on 05 May between 15: 00 and 21: 00, and 06 May between 09:00 and 18:00. To the possible extent, they will be grouped by Clubs.
- 12. Participants who by negligence, omission or delay, don't show up on schedule for a visit or a transport (one-way or return-trip) will have no right to any refund or no opportunity to recover it.
- 13. No electrical connection is planned. For safety reasons it is forbidden to light fires (barbecue, etc), play ball, move vehicles and perform any action that could be dangerous for the participants. Toilet and sewage drainage will be performed without moving the vehicles from 8 to 10 A.M. and from 4 to 6 P.M. or according to the schedule posted by the Organization.
- 14. Dogs must be leashed and walked on the reserved areas. "Accidental droppings" must be picked up in bags and put in the trash. Dogs will not be allowed in buildings, in the tent and in the public means of transportation. Offenders will be warned and may be excluded in extreme cases.
- 15. The Organization declines all responsibility in case of theft, damage or accidents of any type that may occur during any of the activities of 37th EUROCC.
- 16. Each participating crew will receive, at the address indicated on the application form, an envelope with all the necessary information for arrival at destination, and also a card indicating the intended parking area. This card must always be displayed on the windscreen of the vehicle prior to arrival on-site. Each driver must comply with the guidelines of the Organization agents.
